**A MUST ATTEND MEETING** prior to the event for all Captains or their designated representatives will be held at the marina 4pm. Boat numbers and last minute instructions will be given out. Boats will then rendezvous at Lobster Rock Wharf at 8:30pm and the parade will begin at dusk. All boats equipped with VHF radios must monitor channel 68 for further instructions. All boats must maintain proper spacing for safety purposes and follow all health and safety rules, for your vessel.

**Participants must stay in assigned order during judging.**

Trophies and prizes will be awarded after the parade.

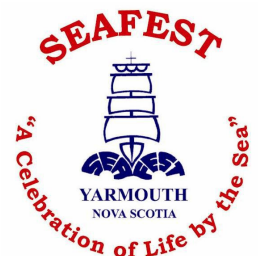
